I would like to take this moment to express my own gratitude for the opportunity to have served as President for the last two years. We have positioned LACSW to have a voice in the emerging digital ethics standards which the licensing board is creating, and have made available ongoing digital ethics and HIPAA training at discounted rates – see the membership section of the newsletter. We have asked for and received a stakeholder's place at the table to provide collaboration and feedback as the LABSWE reviews social work practice rules; have had an active voice regarding changes in the CEU rules and will be paying close attention to digital ethics and ongoing issues with the statute of limitations. We maintain an active presence in the interorganizational group actively reviewing proposed legislation in order to negotiate change prior to presentation in the legislature, which decreases the chance of adverse legislation affecting social work practice while increasing practice protection. We have continued to collaborate with other organizations such as the licensing board and NASW in order to keep clinical social work perspective at the forefront, participated in selection of licensing board members, tracked managed care changes for you and provided interesting, relevant continuing education.

Please renew your membership if you have not yet done so, as your individual dues enable us to continue paying our lobbyist. We are an all volunteer board and thank you very much for your support.

Legislative Committee Report:

There have been 8 major issues we have been following so far this session. Status of those bills is as follows:

HB 381 Passed and signed by the Governor. We testified against this bill. It now exempts from licensure "providers furnishing Behavioral Health services " to Drug Courts. This was sought by judges who said that these services were not able to be provided to persons appearing in drug courts by licensed MH professionals.

HB 385 Passed and sent to the Governor. This changes the Children's Code regarding mandatory reporters. We opposed this bill. It exempts mental health and social services practitioners as mandatory reporters when they are engaged by an attorney to assist in the rendition of legal services to a minor.

SB 8 Pending Senate Judiciary Comm. We opposed this bill. It would criminalize substance abuse by pregnant women.

SB 54 Passed the House. We supported this bill. It would prohibit suspension or expulsion from school any student K - 3rd grades.

HB 270 Passed and signed by the Governor. We supported this bill. It increased timely filing of Medicaid bills. It is a pro-provider bill.

SB 124 Pending Revenue and Fiscal Affairs Comm. We reviewed this bill and were assured that it would not require us to charge tax on our services.

Act 625 0f 2012. We are researching this and have agreed not to advance any legislation on this in 2015 at the request of LABSWE. We will attempt to participate in the LABSWE board meeting and with the Rules Comm. to try to agree to some compromise regarding the statute of limitations. We believe there must be some end date for LABSWE to act on a complaint against a social worker. There are such limits for other MH professionals.

Art therapists were able to pass another study resolution and they will bring a bill again next year attempting to get licensure.

United we stand! Congress just repealed the Sustainable Growth Rate (SRG) and the President (April, 2015) signed it into law, H.R.2, The Medicare Access and CHIP Reauthorization Act (MACRA). This repeals the 21% cut to Medicare claims payments which was due to go into effect. The new legislation removes much of the instability that has plagued the Medicare payment system and our practices. As we know, we must stay diligent and follow legislation closely as this significantly affects the viability of our providing services and to the clients' access to services. We also know that what happens in the Medicare arena affects other insurance and managed care plan rates, and our services, so our diligence is vital. It is hoped MACRA will help with the transition to a new Medicare payment system. Since Congress repealed the SGR formula, services that occurred on or after April 1, 2015 will be paid at the same rate as services furnished before April 1, 2015. We will keep you abreast as we learn more. We thank you for your efforts to stand united through your LACSW membership dues, letters and emails legislatively and working together to maintain the services we provide and advocate for our clients.



LACSW Longings Lessons...Love...Laughs Pioneers on Our Professional Paths-Muriel Pumphrey, DSW by Laury A. Bourgeois, LCSW-BACS

Getting ready to offer a variety of ethics workshops through the end of the year and focusing on ethics during LCSW Supervision; led me to take another look at on-line information. I'd already pulled up one article by Frederic G. Reamer, to share with my supervisees. I'd also planned to write something here about our social work ethics and how to maneuver the minefields that exist when you are working with other professionals who may not have guidelines to follow that are as well defined as ours. Instead, I mined a social work treasure that carried me back to my own undergraduate education; and the woman who got me on the road to becoming a professional social worker: Muriel Elizabeth (Warren) Pumphrey, DSW (1910-2000).

Even though my 1976 undergraduate degree from the University of Missouri-St. Louis (UMSL) was a BA in Sociology; you would have found "With an Emphasis in Social Work" attached to my diploma. I'd already known that Dr. Pumphrey was instrumental in establishing the social work program at UMSL. She'd joined the faculty in 1971, and was asked to teach Sociology the year before I enrolled. In 1976, she was asked to help establish a new department and to get it accredited by the Council on Social Work Education (CSWE). She was successful in receiving the accreditation for the department shortly before she retired in 1980. I've always been grateful to Dr. Pumphrey for the excellent professional grounding I received through coursework, field work, a summer work-study experience in the Buchanan County "welfare department" before graduation, and her personal mentoring. Little did I know; I was in the presence of a pioneer in ethics for social workers.

Dr. Pumphrey was a champion for the inclusion of ethics in social work education. According to Frederic G. Reamer's Evolution of Social Work Ethics: In 1959 Muriel Pumphrey published her landmark work: *The Teaching of Values and Ethics in Social Work Education* for the Council on Social Work Education. As I began looking further, I found many other books and publications. However, the real find was in the Washington University Archives that house the Muriel and Ralph Pumphrey Papers 1934-1993. The works are endless and would take ages to completely review. The collection holds a total of 9 series'. I skimmed the titles in Series 1: Muriel Pumphrey Publications, Papers and Projects and discovered 10 mentions of ethics in 32 folders.



What can you do to become MORE Ethically Engaged?

I wish I could tell you that I'd had deep ethical discussions with Dr. Pumphrey. Instead, I'm wishing I had not been as young in my life and new as a social worker that I didn't see that I was in the presence of greatness and learn more.

If I could sit with Dr. Pumphrey today; I'd first thank her. I'm sure we'd talk about Mary Richmond who first raised issues of social work values and ethics, and then I'd ask for pointers on my upcoming workshops. I can still hear her voice and her unique laugh. I see her smile and how she'd roll around her office in her chair sharing materials. Maybe that ethics aura was rubbing off!

So today, in honor and memory of Dr. Muriel Pumphrey, I share the notion of Ethical Engagement with you. Take a moment. See where you are. And, don't forget:

You never know when you're in the presence of greatness.
